

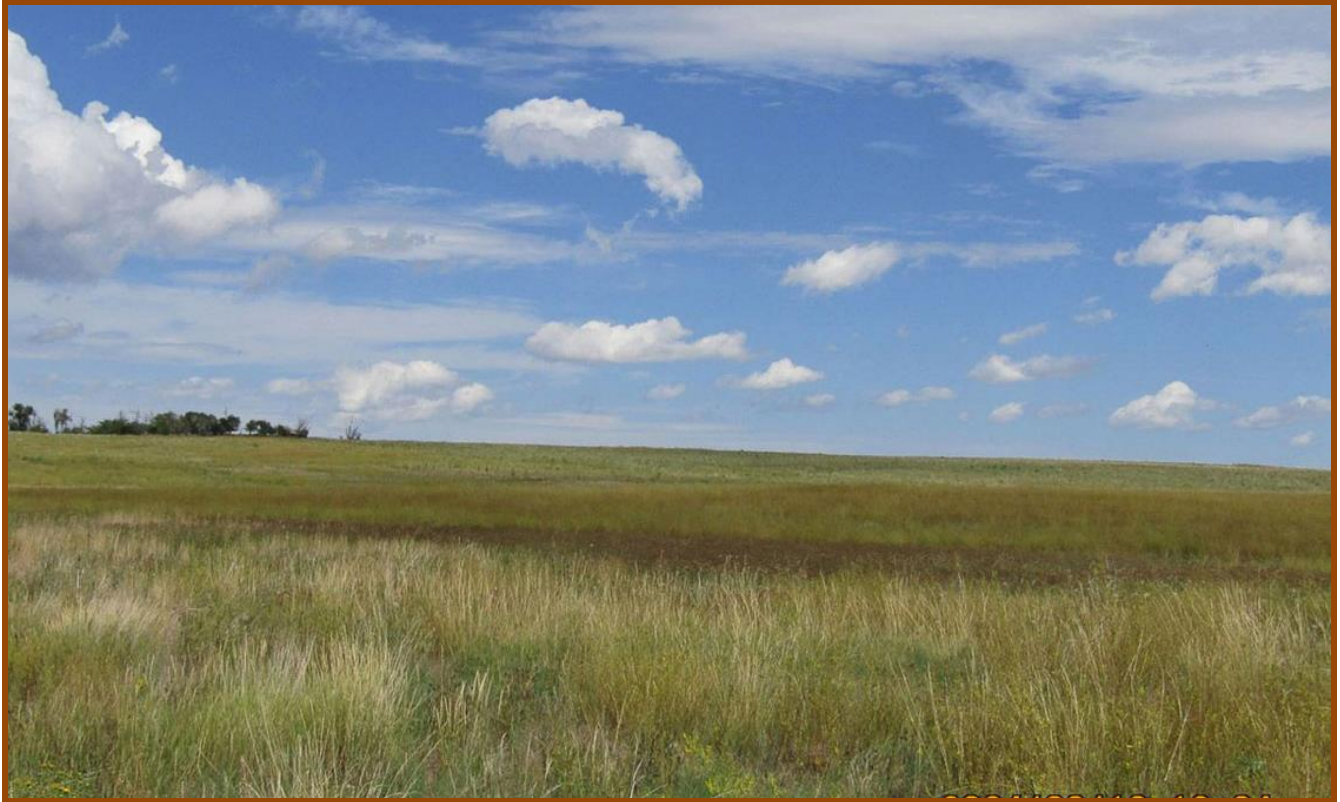

The topography of this CRP features level-to-rolling hill farm ground. The rolling hills common to this part of Nebraska provide excellent farming opportunities as well as outstanding animal habitat. Whitetail deer and upland game birds frequent this property. There are many access points to the property including a county road and section roads. There is a lease with Invenergy Wind Development, North America, LLC, that will transfer with the acquisition of the farm. The property also has a one-year hunting lease associated with it.
